A complete bunker renovation was completed in 2020 and practice facilities, were remodeled in 2016 adding a large short game area, putting green and practice bunker.

With an award-winning Executive Chef and our friendly staff, Edgewood Country Club offers an excellent casual and fine dining experience. Our extensively trained culinary team will keep you coming back for more with seasonal menus and the highest quality of food served and craft cocktails.

Our heated outdoor pool is the place to be during the summer months with the "Edge Bar". The Eels Swim Team also provides a great swim experience for all families and Edgewood Country Club looks forward to hosting the MICSA Finals in 2025.

We are thrilled to announce the completion of our state-of-the-art golf services building which includes a new pro shop as well as three Trackman golf simulators giving our members year round opportunities to golf.

But that's not all - exciting times lie ahead as completion nears on our next series of improvements to further elevate Edgewood Country Club. This project updated nearly the entire clubhouse with a two-lane covered entryway, new lobby, reception area, office, conference room, mansard roof and a lower building enclosure remodel to update the exterior look of the clubhouse.

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, terms of a Young Executive golf member shall not continue after the thirty-seventh (37) birthday of member.) (Once eligibility for Young Executive has expired, a \$1,000 transfer fee will be required to move to Class A membership)

(PLEASE NOTE: Per the Edgewood Country Club By-Laws, proof of Homestead is required for eligibility as Non-Resident member.)

Because of the completion of our capital investments, Edgewood Country Club is enjoying unprecedented interest in club membership. Because of these significant capital investments the club leadership has planned to increased the initiation fee, for all categories of membership, on May 1, 2025. Our Fall Promotion will allow you to enjoy our 2024 initiation fee pricing as represented below.

#### **SELECTED SURROUNDING AREA CLUB DISCOUNT:**

Edgewood Country Club is also offering a reduced initiation fee for prospective members who are current members of selected, surrounding area private clubs. Members of selected, surrounding area private clubs will be eligible for <u>50% off the initiation fees</u> listed above. #### **CONVENIENT STAGED PAYMENT SCHEDULE:**

New members, purchasing their membership during our Fall Membership Initative, may pay their initiation fee with three installments:

#### 1/3 DUE ON WITH APPLICATION 1/3 DUE ON FIRST ANNIVERSARY OF JOINING 1/3 DUE OF SECOND ANNIVERSARY OF JOINING\*

#### **\*POTENTIAL ELIMINATION OF THE FINAL INITIATION FEE INSTALLMENT PAYMENT:**

We have decided to create a "marketing program, within a marketing program" with our Fall Membership Initiative. By purchasing your membership, before the conclusion of the Fall Marketing Initiative, **you may eliminate your final installment payment** by successfully sponsoring a new member into the Club on or before the final installment payment is due and payable. To qualify for the elimination of the final installment payment the sponosred member must be of an equal or higher membership category than the category of membership you joined under.

#### **INCREASING INITIATION FEES:**

There will be a price increase of the initiation fees for all membership categories as of May 1, 2025. The following chart reflects the minimum increase that is anticipated to take effect at the conclusion of our Fall Membership Initative. This is to demonstrate the minimum savings associated with joining during our Fall Membership Initative and a representation of the quality of our newly renovated private club.

Although Fall brings beautiful weather to Michigan there is another season that tends to come right after Fall. Due to the fact we are only going to charge dining member dues (\$165 per month) to all new members through April 30, 2025.

However, all new members **shall enjoy full privileges** of Edgewood Country Club until May 1, 2025. On May 1, 2025 all new members will have usage of Edgewood Country Club commensurate with the membership classification for which they paid their Fall Promotion Initiation Fee.
